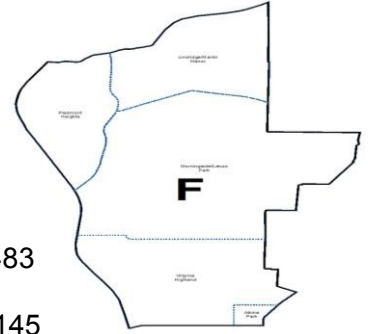

Minutes

1. Opening Remarks/Introductions

The meeting was called to order at 7:00 pm

- Residents of NPU-F may vote on any issue unless there is a financial interest (e.g. property owners may not vote on their own variances, but can vote on other variance applications). Business owners may vote if they have met the requirements as described in our by-laws. Most of our votes will be taken by voice vote.
- Because of the length of the agenda, discussion and debate may be limited throughout the meeting. We use Robert's Rules of Order to keep the meeting moving – so please be patient and follow the cues on when it is appropriate to discuss an issue.

Atlanta Police Dept – Zone 6 Captain Kolotzer; Zone 2 Captain Butler

- Crime remains down for the year with our most significant crime continuing to be care break-ins. There has been a small increase in auto thefts which is believed to be a crime of opportunity when thieves find a vehicle with keys left in the vehicle. Package thefts are also continuing to be a problem and residents are encouraged to use alternate deliver locations.
- We have seen protests in response to incidents in Charlottesville and elsewhere. APD expects these protests to continue.
- With regard to Peachtree-Pine, some residents have already been transitioned out. APD is working with other local agencies to make sure the problem is not just pushed out into the surrounding neighborhoods. Nightly sweeps are being conducted of city parks to prevent homeless camps from being established.

Fulton County Community Prosecutor - Zone 2 - Brendan Dougherty

- Provided an update on the recent CourtWatch training program held on Saturday August 19th.
- He also reported on three initiatives being pursued by the Fulton County District Attorney's office.
 - First, they are requesting that the county renew funding for Narcan/Naloxone. If every first responder is equipped with these drugs, heroin overdoses can be reversed quickly and lives saved.
 - Fentanyl is becoming increasingly popular as a street drug and is extremely dangerous as it is ten times more powerful than Heroin. First responders are at risk of severe reactions and even death if exposed to this drug in some forms. The DA's office is asking Fulton County Commissioners to sponsor a resolution to purchase protective gear for officers in all municipalities within the county who may encounter this drug.
 - The DA's office is taking advantage of property forfeiture laws to seize property which is then being turned over to Habitat for Humanity to rehab and provide housing for families or for police officer housing.

MARTA police – Sgt. Mosley

- Seeing more loitering in train stations with the closing of the Peachtree/Pine shelter. They are deploying more plain clothes officers to address this issue and the issue of fare evasion. Since the beginning of this initiative they have arrested more than 500 fare evaders. This crime results in significant loss of revenue for the system.

Bureau of Housing and Code Compliance – Officer Edwards (sledwards@atlantaga.gov cell 404-326-6573)

- Actively working to identify properties that need overgrowth cut or graffiti removed. She requests that residents report any problem properties.
- The department has now hired eleven research technicians which is resulting in being much more effective at locating property owners and being able to pursue and close cases.

Office of the Solicitor's - Andrew Hughes, Solicitor - excused

Watershed Management – not present

A discussion was led by Rich Sussman regarding a recent communication from the Ombudsperson requesting that residents adopt and care for catch basins to keep them free of leaves and other debris

that contribute to flooding during storms. Residents suggested that more frequent street cleaning by the city would greatly aid in solving this problem as evidence by programs in other parts of the country. It was also suggested that conducting street cleaning on days when trash, recycling and yard waste pick-ups were NOT scheduled would greatly aid in the effectiveness of street cleaning.

- Support for Noble Park in Morningside (MLPA Supports). A park plan was reviewed and a 100K grant is being sought from Park Pride. Matching funds have been raised. Rich Sussman made a motion to support this project and the motion carried on voice vote.
- Support for Armand Park in Lindridge-Martin Manor (LMMNA Supports). This park project is looking for a 250K legacy grant from Park Pride. A motion to support the project carried on voice vote.

Chair Report:

- By-Laws must be approved and submitted to the City Office of Planning next month. The Emory Annexation will require changes to the by-laws and suggest that we submit the 2017 by-laws without any changes and amend them as necessary following City Council’s approval of the annexation. The current by-laws are on the NPU-F website.
- Reminder that NPU-F elections will be held in November. Please let me know if anyone is interested in an NPU F leadership role. The Vice-Chair role is now vacant and I’m looking for a volunteer.
- The Rock Spring Presbyterian Church rezoning application is on hold again. The developer is considering his options after the church has rejected a proposed covenant between the church, developer and the Piedmont Heights Civic Association that would primarily preserve the church and restrict any expansion. These covenants are required as a condition of approval by the NPU.
- APAB met last Saturday. Two items of interest: the APAB Transportation committee is looking at the issue of protected bike lanes being removed (either permanently or temporarily) and whether it is allowed without City Council action. They have just started looking into this issue that could have an impact on the frequent closing of the cycle track on 10th street for special events. Also, additional appointments have been made to the Beltline TADAC. APAB has a total of 13 seats with a few more vacancies. If you are interested in serving, see Debbie.

<p>Comments: 10th street from Monroe to Charles Allen will be closed from Friday September 8th through Friday September 22nd. The event will run from noon – 11 pm on Saturday and noon to 10 pm on Sunday. Sound check will take place on Friday evening from 5 – 9 PM. Cleaning will take place from 10 – 3 am on Sunday night into Monday morning and then crews will return at 6 am on Monday. Live Nation is making a 10K donation to Grady PTA and a 10K donation to Grady Athletics. Music stages are being rearranged so that the stage nearest 10th street can be assembled more quickly, but this will have no impact on acoustics. The presenter was unaware of any other contributions to the community. In addition, she was unable to answer questions about how far into the neighborhood clean-up would take place. Residents expressed concern about the loud music occurring so late on Sunday night (a school night), the impact on 10th street, and land-locked streets between Monroe and the park. Sentiment was strong that the vote of the NPU would not affect whether this festival goes forward as planned.</p> <p>NPU-F Action: Motion to support was approved by a vote of nine in favor, and five opposed.</p>

Board of Zoning Adjustment (BZA)
(Vote Required)

V-17-197 569 Elmwood Drive

Applicant, Charles R. Bobo II, seeks a variance from the zoning regulation: (1) to reduce the required western side yard setback from 7 feet to 3 feet, (2) to reduce the required rear yard setback from 15 feet to 7 feet (with alley credit), (3) to increase the maximum impervious lot coverage from 50 percent to 60 percent, and (4) to increase the maximum size of an accessory structure from 30 percent of the principal structure to 48 percent in order to construct an accessory structure.

VHCA Report: After two sets of revisions, owner Charles Bobo now seeks a reduced number of variances to construct a new accessory building that will hold two cars with a living space above in the rear of his property: (A) a reduction in the western side yard variance from the required 7' to 3' and (B) a reduction in the required rear setback from the required 15' to ', with credit for an additional 5' in the adjacent rear alley. The main structure will also be enlarged with a new basement; no variances are required for that.

The adjacent neighbors have been notified; one tree will be lost. The living quarters are intended to house a caregiver for his mother, a permitted use in R-4. Mr. Bobo is aware that the rental of the living space for most other uses in R-4 is proscribed. The VHCA Board recommended approval 6-1, conditioned on the proper filing of new plans with the city by the NPU meeting identical in content to those shown at the Board meeting dated 8-14-17.

NPU-F Action: Referral certificate has been amended to add front yard setback reduction (this is an existing condition) and eliminate (3) lot coverage increase and (4) accessory structure increase. Motion to recommend approval of the setback reductions on the west and rear yard carries on voice vote.

V-17-200 1831 Homestead Avenue NE

Applicant, Gail Mooney, seeks a variance from the zoning regulation to reduce the required half depth front yard setback from 17.5 feet to 12.5 feet for an addition.

MLPA Report: Approved 13-0-0

NPU-F Action: Motion to recommend approval carries on voice vote.

V-17-210 836 Yorkshire Road NE

Applicant, Mark Arnold, seeks a variance from the zoning regulation: (1) to reduce the required front yard setback from 35 feet to 30.7 feet, and (2) to reduce the required west side yard setback from 7 feet to 2.8 feet to construct a second story to a single-family home.

MLPA Report: Approved 13-0-0

NPU-F Action: The referral certificate has been corrected to reflect that this is a 2nd floor addition and not to construct a garage. Motion to recommend approval carries on voice vote.

V-17-211 1727 North Pelham Road NE

Applicant, Mark Arnold, seeks a variance from the zoning regulation: (1) to reduce the required north side yard setback from 7 feet to 3 feet, and (2) to reduce the required rear yard setback from 15 feet to 3 feet to construct a garage at the rear of an existing single-family dwelling.

MLPA Report: Approved 7-3-3

Comments: Residents on the east side of this property object to the variance arguing that they were not provided sufficient notice of the MLPA meeting and that the applicant has other options to rebuild their garage which was damaged when a tree fell. Complainant had sufficient time to present objections at NPU meeting and may argue their case in front of the BZA.

NPU-F Action: Motion to recommend approval carries on hand vote with nine in favor and six opposed.

City of Atlanta Code of Ordinances

(Campaigning by Elected Officials & Candidates)

As we prepare for 2017 Elections please allow this message to serve as a reminder of the City of Atlanta's Code of Ordinances. Voting will involve municipal, county and state elections. The Guidelines for campaigning by elected officials at NPU and APAB meetings is strictly prohibited by the City of Atlanta's Code of Ordinances. Please note the following code section:

SEC. 6-3019 Prohibition of Political Forums

Part 1, Chapter 6, Article 1, Section 6-1: "It shall be unlawful for any person to use the interior of city hall, its rooms or offices in any type of advertisement of commercial products and political campaigns without first obtaining express permission from the city council. This prohibition shall apply to the filming or photographing of the interior of city hall for use in such advertisements; provided, however, that nothing in this section shall be construed to prohibit the filming or photographing of the interior of city hall for news coverage purposes by newspapers, magazines and television."

Part 6, Chapter 3, Article B, Section 6-3010: "Neighborhood Planning Unit meetings shall not be used for political forums or campaigning for city, county, state, or federal elections."

Examples of campaigning could include, but not be limited to:

- Introduction of elected officials as political candidates in upcoming elections;
- Passing out campaigning materials and literature; and
- Conducting either of the above in city hall, its rooms or offices.
