#### **AGENDA**

1. Opening Remarks/Introductions

The meeting was called to order at 7:00 pm.

The Chair received a request to add an alcohol license application to the agenda for Carlyle's at 1919 Piedmont Road. The request is for a clarification of the NPU's condition placed on our approval.

We Also received a request from Sisters by Choice to tell us about their 15<sup>th</sup> annual 5K at Piedmont Park on July 20<sup>th</sup>.

**NPU-F Action**: Motion to add the Sisters by Choice 5K and Carlyle LRB application to the agenda carries on voice vote.

2. Approval of Minutes

The May 2019 minutes were posted on the new NPU-F website. There were no changes or modifications noted.

- 4. Reports from City Departmental Representatives
  - Atlanta Fire Rescue Department Station 19 North Highland; Station 29 Monroe Captain Durrah Battalion 3 (housed at Station 15 on 10<sup>th</sup> Street) spoke to us about the Closed Door Campaign. He recommended that we sleep with our bedroom door closed so that, in the event of a fire, there is a barrier to prevent smoke and fire from entering the room. If there is a fire and occupants need rescue, he advised that we should close doors to buy time until firefighters can reach us.

AFRD hosted an open house at Station 15 (10<sup>th</sup> street "The Night Train") on June 1st.

The Atlanta Fire Rescue Department again maintained Class 1 ISO rating which is good for our insurance rates. Because of the high regard for AFRD, they are hosting firefighters from other

countries to show them how Atlanta operates. On June 10 members of the Belgian consulate visited for a demonstration and Saudi Arabian firefighters will be here soon to ride along with our people, help with calls and learn.

The next recruit class graduates in November.

Blue lights are being added on new fleet vehicles to help alert people especially on the highway. Sgt. Darrow Harden, who was severely injured when a vehicle struck him as he was exiting a firetruck on the connector, was released from the hospital to the Shepherd Center for rehab. He is now home and continuing rehabilitation.

# Atlanta Police Dept. - Zone 6 - Captain Clay Zone 2 - Sgt. Somers

Captain Clay (<a href="mailto:abclay@atlantaga.gov">atlantaga.gov</a>) showed before and after of photos of homeless encampments that have been cleaned up recently. Though larcenies from vehicles in beat 613 are down from the extreme high in April, there were still 14 larcenies in May. In addition, 4 cars were stolen. Of these, two had the keys in the car and it was running.

He also reported that APD has started to enforce scooter violations – especially when they observe someone riding on the sidewalk. Scooters must be ridden in the street the same as any other motorized vehicle or bicycles, and helmets should be worn for safety.

Sgt. Somers and other officers recently received additional training on dealing with pay parking. He discussed the rules for attended parking lots. If someone is charging for parking, they must have a have a permit, and all staff should be in uniform. There are two categories. Park for Hire refers to paid parking on private property. However, if the vehicle touches public property (for example if you drop your vehicle in a driveway of a restaurant and the attendant drives the vehicle to a lot elsewhere (therefore using public roads) then it is considered valet. He also noted that if the public road is state controlled (such as Ponce de Leon Avenue) then the operator needs a state permit.

Officer Edwards reports that they are trying to get a hold on LLCs (absentee landlords especially).

Residents are reminded that the new rules regarding bulk pickup begin July 1<sup>st</sup>. Each household is permitted 12 free bulk pickups per year, but we must call 311 to request the pickup before placing items at the curb. Those who leave items at the curb without calling ahead will be cited starting July 1<sup>st</sup>, 2019. The fine will be \$325.

One resident asked about a mess at the corner of Lindberg and Cheshire Bridge. This is on the north west corner at the bench near the BP Station.

- Education Committee (vacant)

#### Chair report:

- Fete du Rose cancelled last month we were notified that this event had been rescheduled from its original date in May. It has now been cancelled.
- Atlanta Moon Ride postponed— appeared before the NPU last month. They have moved their date to June 21<sup>st</sup> due to inclement weather. AMR has updated their street signs.
- Atlanta Blaze Block party in Piedmont Park received notification that an application had been filed by the Mayor's Office of Film and Entertainment to hold 5 pre-game tailgate parties at Piedmont Park, on June 2, 8, 21, July 7 and August 3<sup>rd</sup>, with a projected attendance of 200. The Atlanta Blaze will be playing their home games at Grady High School. The application was filed on May 23<sup>rd</sup> missing the deadline by 2 ½ months. Debbie attended a meeting of the Midtown Neighborhood Association's LPC (License and Permits Committee) to learn more. MNA is in NPU-E and the 1<sup>st</sup> date was before the NPU would meet. MNA asked that they not hold the first event. Most of the discussion was around the timing of the application leaving several questions regarding the event itself– including the set-up appearing to be for more than 200 people. NPU-F has not received a copy of the application and has not been asked for a recommendation at this time.
- The Man Cave LRB application has still not been scheduled for a License Review Board meeting. Will keep you informed if/when it is scheduled. LRB hearings are held every other Tuesday at City Hall at 5 pm. We haven't been able to get any info from the applicant or the City on the status. Some activity has been observed at the location and neighbors have been asked to keep an eye out.
- Emory University Parking Overlay Legislation Emory University has asked that the City work with them on a plan to reduce their parking requirements anticipating future construction projects and their shared parking facilities. The original recommendation was a special exception parking reduction which would reduce their parking requirements to 0 not Emory's intent so that was scrapped and legislation to create a parking overlay has been drafted. The principles of the legislation are that there are no parking minimums (consistent with the QOL zoning districts), available parking is shared and is used on a 24/7 basis for classrooms, hospitals and staff, Emory has a robust alternative transportation

policy, as will be recorded in their master plan and includes bike lanes and bus shuttle system. Adraft has been distributed to members of the Zoning Committee and to the Druid Hills, Mason Mills and Victoria Estates neighborhoods as a heads up. Note that legislation is still in draft form, but we should receive a finalized version before our July meeting when it will appear on our agenda and a vote will be taken.

- **APAB meeting** June 15<sup>th</sup> 3 presentations were given at this month's APAB meeting:
  - Beltline TADAC 2018 Annual Report which summarized the work of the TADAC. A new chair (one of the APAB representatives) is anxious to improve the community involvement and attendance at TADAC meetings.
  - MARTA announced a Transit Station renaming project and asked APAB for input on how the names should be selected (by geography, historical references, or by selling naming rights to corporate sponsors). Stations to be renamed include Ashby Street and Bankhead MARTA stations (names of street has changed), Civic Center Station (Civic Center has closed), Dome/GWCC/Philips Arena/CNN Center Transit Station (Phillips Arena has been renamed) and Lakewood-Fort McPherson Station (Fort McPherson is closed.)
  - Leah LaRue gave a presentation on the recently moved NPU team to the Office of the Commissioner from the Office of Zoning and Development. She explained that one of the driving reasons was that the NPUs receive information from 4 city offices, not just OZD, and the other applications had not been less of a priority. Leah also distributed a letter from her office notifying NPUs that they could no longer REQUIRE an applicant for an LRB application or special events application to attend any other meeting (like a neighborhood meeting or committee meeting). This raised concerns from several NPUs who, like NPU-F, send their applications to their neighborhoods for review and recommendation. APAB is establishing a sub-committee to review the legislative requirements for NPU reviews and make recommendations on what changes will need to be made to ensure that neighborhoods and NPUs have an opportunity to review applications and negotiate changes with applicants.

On Consent agenda – 2<sup>nd</sup> story

Applicant seeks a variance from the zoning regulation to 1) reduce the required front yard setback from 35 feet to 31.7 feet and 2) reduce the required half-depth front yard from 17.5 to 7.6 feet for the construction of a second story addition to an existing single-family home.

**VHCA Report:** Owner/applicants Jessica and Preston Smith are requesting a variance to 1) reduce the front-yard setback from 35 feet to 31.7 feet (existing) and 2) reduce the half-depth side-yard setback from 17.5 feet to 7.6 feet (existing). This variance will allow for the construction of a second-story addition to the home. Lot coverage is already over the allowed amount at 54.78%. The application does not include an increase to the lot coverage and the applicant/homeowner has expressed interest in reducing impervious lot coverage even further as the project continues. No tree impacts were reported. All adjoining property owners were notified of the application. Virginia-Highland Board of Directors and Planning Committee voted unanimously to support this application.
